Objectives and investment policy

- The Goodbody Global Smaller Companies Fund ("the Fund") seeks to provide long term capital growth primarily through investment in global equity securities of small and medium sized companies with geographical and industry sector diversification.
- The Fund invests in a diversified portfolio of small and medium sized companies that offer attractive and sustainable growth opportunities over the long term. The goal of the Fund is to identify smaller companies that have established profitability and to hold those companies over the longer term while they deliver future growth. It is the growth of cash flow and earnings which is ultimately expected to drive share price returns over the medium to long term.
- Whilst it is the intention that the Fund be principally invested in equity securities, the Investment Manager retains the flexibility to invest substantially in cash and/or money market instruments such as treasury bills where market conditions so warrant and/or the Investment Manager considers it to be in the best interest of the Fund to do so.

- The Fund may invest up to a maximum of 20% of its Net Asset Value in emerging markets
- All income and gains generated by the Class E EUR Accumulation Class will be reinvested. No dividends will be paid for the Accumulation Classes. All income and gains generated by the Distributing Classes may be distributed.
- On demand, you can buy and sell Shares in the Fund on any Business Day.
- The Class E EUR Accumulation Shares are denominated in Euro ("Euro").
- The Fund is appropriate for investors with a long term investment horizon.
