Objectives and investment policy

- The Goodbody Dividend Income Growth Fund ("the Fund") seeks to achieve stable long-term growth in both capital and income by investing in a diversified portfolio of global equity securities.
- The Fund seeks to invest in companies which currently pay or are expected to pay dividends and have both the capacity and intention to progressively grow these dividends over time.
- Whilst it is the intention that the Fund be principally invested in equity securities, the Investment Manager retains the flexibility to invest substantially in cash and/or money market instruments such as treasury bills where market conditions so warrant and/or the Investment Manager considers it to be in the best interest of the Fund to do so.
- The Fund may invest in exchange traded funds (ETFs) (a marketable security that tracks an index, a commodity, bonds, or a basket of assets like an index fund). Any investment in such instruments will provide indirect exposure to global equity and fixed income markets. Investment in ETFs will be limited to 10% of the Net Assets of the Fund

- The Fund may invest up to a maximum of 20% of its Net Asset Value in emerging markets
- All income and gains generated by the Class B EUR Accumulation Class will be reinvested. No dividends will be paid for the Accumulation Classes. All income and gains generated by the Distributing Classes may be distributed.
- On demand, you can buy and sell Shares in the Fund on any Business Day.
- The Class B EUR Accumulation Shares are denominated in Euro ("Euro").
- The Fund is appropriate for investors with a long term investment horizon.

- The risk and reward indicator is calculated on the basis of the share class volatility (the ups and downs in its value) over the prior 5 year period. As the Fund was approved by the Central Bank of Ireland on the 11 December 2015 there is insufficient fund history to provide a useful indication of the Risk and reward profile. 
Charges
