Month in Review

Equity markets rose in June. World equities rose 1.2% in euro terms. Japan was the strongest performer - followed by Europe and Small Cap. US and Emerging Markets were the weakest performers. Health Care, Financials and Industrials were the strongest sectors. Communications Services, Energy and Materials were the weakest. Euro area bond markets rose by 0.4%.

Global equity markets delivered positive returns during June but much of this gain came from the stronger US dollar which boosted returns in euro terms. In fixed income, European bond markets delivered modest positive returns as government bond yields moved lower across most regions, supporting sovereign debt prices.

Safran, iShares S&P 500 Health Care Sector UCITS ETF and Visa were the best performers. London Stock Exchange, X Trackers MSCI World Communications Services UCITS ETF and Wolters Kluwer were the weakest performers. Within fixed income, Pimco GIS Euro Income Bond Fund was the best performer and Aegon European ABS Fund was the worst performer.

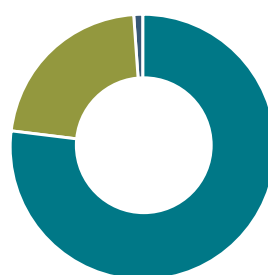
Regional Allocation as at 30 June 2026
