Month in Review

Equity markets declined in July. World equities declined 0.5% in euro terms. Europe was the strongest performer - followed by US and Small Cap. Japan and Emerging Markets were the weakest performers. Energy, Financials and Consumer Discretionary were the strongest sectors. IT, Utilities and Industrials were the weakest. Euro area bond markets declined by 1.5%.

Global equity fell in July as the positivity around strong second quarter earnings was offset by concerns around geopolitical risks and the sustainability of returns in a number of AI connected sectors. In fixed income, Government bond yields rose as higher energy prices and favourable economic data increased the potential for rate rises.

Wolters Kluwer, Blackrock and Xtrackers MSCI World Energy UCITS ETF were the best performers. CRH, iShares NASDAQ 100 UCITS ETF and First Trust Nasdaq Clean Edge Smart Grid Infrastructure UCITS ETF were the weakest performers. Within fixed income, Aegon European ABS Fund was the best performer and BlueBay Investment Grade Euro Government Bond Fund was the worst performer.

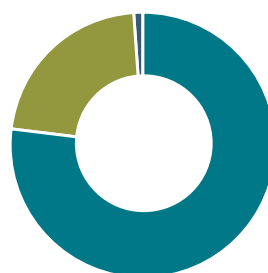
Regional Allocation as at 31 July 2026
