Month in Review

Equity markets rose in January. World equities rose 1.7% in euro terms. Emerging Markets was the strongest performer - followed by Japan and Asia Pacific ex Japan. US and Europe were the weakest performers. Energy, Materials and Industrials were the strongest sectors. Financials, Consumer Discretionary and Health Care were the weakest. Euro area bond markets rose by 0.7%.

Equities experienced volatility in January but gained on rising economic growth expectations, satisfactory inflation data and strong Q4 US earnings. Emerging Markets performed strongly helped by gains in AI related equities while Japan benefited from the prospect of positive political developments. Euro bond markets rose helped by a decline in French Government bond yields.

Xtrackers MSCI World Energy UCITS ETF, Siemens and iShares Core MSCI EM IMI UCITS ETF were the best performers. Wolters Kluwer, Visa and London Stock Exchange were the weakest performers. Within fixed income, Bluebay Investment Grade Bond Fund was the best performer and Muzinich Enhancedyield Short-Term Bond Fund was the worst performer.
