Month in Review

Equity markets rose in August. World equities rose 1.8% in euro terms. Japan was the strongest performer - followed by Emerging markets and Asia Pacific ex Japan. Europe and US were the weakest performers. Materials, IT and Energy were the strongest sectors. Utilities, REITs and Consumer Staples were the weakest. Euro area bond markets declined by 0.5%.

Investor sentiment was boosted by strong earnings from a number of the US mega cap companies (Nvidia, Microsoft and Amazon) and other AI-related stocks (Caterpillar and Palantir). Fixed income markets came under pressure as minutes from the ECB's July meeting revealed that some policymakers had favoured a rate hike.

London Stock Exchange, Uber Technologies and iShares S&P 500 Information Technology Sector UCITS ETF were the best performers. Xtrackers MSCI World Consumer Staples UCITS ETF, Otis Worldwide and CRH were the weakest performers. Within fixed income, Muzinich Enhancedyield Short-Term Bond Fund was the best performer and SPDR Bloomberg Barclays Euro Aggregate Bond UCITS ETF was the worst performer.

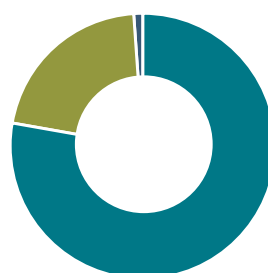
Regional Allocation as at 31 August 2026
